Special Event Plan Review Fees (no fee discount, available in district only)
includes temporary tents/membrane structures, carnivals/fairs, exhibits and trade shows, fireworks displays or any other large assembly function.

\$188.00 per event

Includes plan review and 1 inspection during normal business hours for permit issuance.

For inspection requests during non-normal business hours add \$196.00 per hour, minimum 2-hour charge to permit fee to be paid prior to inspection.

Additional inspections

\$157.00 per hour, 1 hour minimum during normal working hours

\$196.00 per hour, 2- hour minimum for inspections during non-business hours

Site Plan Review (no fee discount, available in district only)

\$94.00 Includes 2 reviews and 1 inspection

Additional reviews are charged at \$94.00 per hour, minimum charge 1 hour.

Additional inspections are charged \$157.00 per hour, minimum charge 1 hour.

Board of Appeals Hearing Fee

\$500.00 per appeal

Includes 1 appeal board hearing.

**** All fees shall be paid before a permit can be issued, requests for inspections, or approvals for occupancy.**

Special Note: Performing work without a permit, the permit fee is three times the normal applicable fee.
